The executive director met with students, parents, city officials, and local community college personnel to discuss community and school needs during the months of September and October 2021. School leaders also met with all school educators on every Wednesday from August to October 2021 in the Leadership Planning Committee (LPC) meetings to obtain feedback and input regarding areas of need. Administrators met with student leaders during and after school to discuss improvement strategies. Lastly, a public notice was issued to notify community members that a virtual meeting was held on 10/29/21 to discuss this expenditure plan. To our knowledge, none of the required community members expressly identified themselves as representatives of tribes or

civil rights organizations. Although we were not aware that we were required to specifically contact these groups, we will solicit their input via a variety of methods (i.e. email and social media) in January 2022.

The information collected by school leaders was evaluated to develop a comprehensive needs assessment. Based on this information, school leaders prioritized each item to address the most critical areas that would provide the greatest benefits to students. Specifically, stakeholders expressed the need for mental health training and services, additional space for special education instruction, isolation room(s), and improved security systems.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
